**ADMINISTRATIVE ORDER**

AND NOW, this 14<sup>th</sup> day of June, 2021, the Governor of this Commonwealth, in coordination with the COVID-19 Vaccine Legislative Joint Task Force, having ended all state-imposed COVID-19 restrictions, including those pertaining to masking, as of Monday, June 28, 2021, it is hereby ORDERED that Administrative Order No. 25-2021 extending the Judicial Emergency in the Second Judicial District resulting from the COVID-19 pandemic through August 31, 2021, is AMENDED as follows:

1. Pursuant to the Pennsylvania Department of Health, mask and face covering requirements and all social distancing requirements for court users, court personnel, and members of the public who enter any courtroom or Court facility, as set forth in previous Administrative Orders, are lifted as of June 28, 2021. Nothing in this Order precludes anyone from wearing personal protective equipment if they choose to do so or if required by an entity over which the Court has no jurisdiction.


2. All Court facilities within the Second Judicial District shall be immediately accessible without restrictions, except for the Law Library which shall remain accessible by appointment only for members of the public.
